Broadband Fair Use Policy

AIM OF THIS POLICY

This policy aims to ensure we are able to provide quality service to all of our customers and to ensure no customers are disadvantaged by the behaviour of others.

EXCESSIVE USE

To ensure the availability of our services to all eligible customers, if you are an excessive user of the Broadband through downloading or uploading large volumes of information or data, we may ask you to reduce your usage of the service. If usage continues at an excessive level, we may refuse you access to this service.

UNREASONABLE USE

In addition, where we consider your use of the Broadband service to be unreasonable, then we may suspend your access to that or any other promotion immediately and without notice to you.

Without limiting the meaning of 'unreasonable':

- (a) we supply the service for the purpose of you making an internet connection from your home, on our network for your own personal use and not for any commercial purpose. We consider your use of the service to be unreasonable if you use the Broadband service other than for your own personal use.
- (b) we also consider your use of the service to be unreasonable if:
 - (i) your usage of the service affects other customers' access to the network; or
 - (ii) you wholesale any service or use the service in connection with any device that switches or reroutes the service or by potentially keeping a line open for hours;

UNLAWFUL USE

Use of the Village Baxter Broadband Internet Service to access materials prohibited by any Australian Law will result in immediate termination of access to the Village Baxter Broadband Internet Service.

Use of the Village Baxter Broadband Internet Service in a manner which breaches any Australian Law will result in immediate termination of access to the Village Baxter Broadband Internet Service.
